Race to the Finish Line

Data News Weekly Interview Ray Nagin and Mitch Landrieu

The final days before the historic May 20th run-off election is upon us, as citizens prepare to get to the polls to cast their ballots candidates are spelling out their platforms, and placing ads on television, radio, and newspapers in an effort to attract voters. Although several offices are up for grabs including several city seats on the City Council, Clerk of Civil Court and the Assessor's Office, the most watched of these races is for the Mayor of the City of New Orleans. This contest has incumbent Mayor Ray Nagin pitted against Lt. Governor Mitch Landrieu for who will lead New Orleans in its rebuilding. Data News Weekly had the unique opportunity to interview both candidates in a Data News Weekly exclusive.

EB: How does it feel to be in the run-off?

ML: I am proud that my votes came from across all parts of the city. I had an equal share of white and black, and since the election I have picked up endorsements from both the Republican and Democratic parties, ministers businessmen, elected and officials and law enforcement agencies. We campaigned as we will govern, reaching out to all neighborhoods and communities in our city and in our victory the center held, rejecting the divisiveness that threatens to pull our city apart.



EB: A lot of people have heard your name and the campaign slogans, but can you tell us a little bit about Mitch Landrieu the person and why should the citizens elect you as Mayor of New Orleans?


ML: I have been at the forefront of some of Louisiana most sweeping reforms over the past years. I have always tried to make government work better, smarter and help those who need a voice.

I will bring that same energy, dedication and passion for public service to the Mayor's office. I will be responsive, honest, and tough. I understand the basic responsibilities of city government, and I will restore credibility to the Mayor's

EB: What is it that you feel are major differences between yourself and the present Mayor?

ML: I bring a record of reform and results through leadership I have the ability to bring people together through communication. City government as it is today is not meeting its obligation to the citizens of New Orleans. Our people need answers and action from their leadership and they need it now. Our city needs a steady leader who can bring people together (not divide), stick to a plan and get results.

EB: If elected what would be the first thing you would do as Mayor? And how would your administration be different from the previous Mayor?



EB: How are things going with your campaign?

RN: It's been an interesting election cycle and we're getting ready for the actual run-off election; everything is going well.

EB: Were you surprised by the outcome in the primary election?

RN: No I think we had some great pollsters in Dr. Silas Lee who had been tracking this thing pretty close. And we had a good sense of where it was going. The only disappointing thing is that we thought we would do better in the White community where we thought we would get about 15% of the vote and we ended up getting six to eight

percent of the vote, other than that everything came up like we expected.

EB: How would you assess your four years in office?

RN: I would say I've done quite well, we had a lot of success prior to Hurricane Katrina. The economy was headed in a positive direction, we were taking a lot of people off the poverty rolls, we had increased home ownership, we had HUD redeveloping public housing with new mixed income communities, and our real estate market was hot. Then Katrina hit and it changed everything.

EB: If you are re-elected for another four years what will be on your agenda? **RN:** We're going to continue to re-develop, and repopulate this city and we're going to do that in a manner which would hopefully eliminate all the blighted properties that were in the city. We are hoping to add new transportation mediums like light rail in our city; also I'm hoping to develop the riverfront. It is about to be a great time for New Orleans; this city is about to experience an economic turnaround. And by taking advantage of this incredible economic boom, we can create an environment for economic equity where everybody gets a chance to take a big bite out of this economic pie and expand it. I'm looking forward to a city that

EB: What's a realistic timetable for people to consider coming back to the most devastated areas of the city?

RN: Well it depends; I think the Gentily area the 17th Street Canal and New Orleans East are poised and ready for growth. The most challenging area we have

MIL: Hire professionals that are diverse and dedicated to rebuilding the city. My administration will be diverse and we will be accountable for results. I will build a team of professionals that will bank with community lenders and will stay dedicated to implementing a plan.

EB: The city just released its New Evacuation Plan if elected would you stay with the plan submitted by the present Mayor, or would you make amendments to it, if so what would they be?

ML: Mayor Nagin made an announcement just over a week ago, but with just days left until the next hurricane season, the city still does not have a concise and rehearsed emergency preparedness plan that has been communicated to the citizens or surrounding parishes.

First, I will coordinate with other parish leaders and the federal government to make sure everyone is on the same page.

Immediately I will begin to work with the state, federal government and the U.S. Conference of Mayors

to assist us in developing sistercity agreement for evacuations. Appoint an emergency preparedness coordinator.

I will have national experts evaluate our short and long term needs. Components of an emergency plan will include:

- A clear chain of command
- Timelines for securing critical city assets
- Plans for emergency coordination and communication among key emergency personnel
- A re-entry and recovery plan addressing debris removal, energy restoration, the return of residents and businesses, and environmental, health, and safety issues.

EB: For the people who are scattered about the country and have the desire to come home, what is a realistic time frame they should consider before returning to New Orleans?

ML: We will work with all citizens who have the desire to return home by providing them access to information they need to make informed decisions. Our people need more than encouragement to come home;

they need specific information, including:

- Homeowners/renters assistance programs
- Availability of city services in their neighborhood
- Vulnerability to future hurricanes

EB: Your opponent has attacked you saying you have been absent and ineffective in your tenure in public office; tell us about some of the things you've done since you've been in elected office?

ML: In my 18 yrs of public service I have a record of reform and leadership.

- In 1988 I chaired the commission that worked to consolidate city government including the assessor's office.
- I lead the juvenile justice reform movement in Louisiana
- While on the House Ways and Means Committee I helped make possible the construction of major economic development projects the Morial Convention Center expansion, the New Orleans Arena, the National D-Day Museum as well as improvements to the contemporary Arts Center and the Children's Museum.

• Driving the Bio Tech Initiatives and pushing for education reform.

As Lt. Governor I led the efforts to restart New Orleans' tourism industry. Immediately after the storm, I brought industry leaders and national experts together to develop a strategic plan, Louisiana Rebirth. I also launched cultural economy initiative which was designed to create jobs through La. Unique culture - our food, music, arts, film, and architecture. Through smart investment we have been able to return \$15 for every \$1 we spend marketing the state.

EB: Some of your critics talk about not returning to the politics of old, do you think that your being a Landrieu could prove to be a political liability, or is it an asset, or do you think it has no bearing on your ability to govern?

ML: I believe my 18 yrs of experience and relationship building is an asset in making government work. I am confident I can get the job done. Ask anybody who has worked with me; I am honest, independent and able to get this done.

EB: As you speak with the constituents what are they telling you they want to see in the 'new' New Orleans?

ML: They want strong leadership, a plan and a person that can implement that plan. They want to see the credibility of our city restored nationally and internationally. They want their government to speak with one voice to the legislature and governor in Baton Rouge and in Washington to the Congress and the President. They want answers about what the city will look like and how they can come home.

EB: Before we finish, if there is one thing you could say to the residents of New Orleans who are all over the country right now, what would you tell them?

ML: I ask you not only to trust my vision for this city, but my record. We have a once in a life time chance to create a city and a government that works for us all. Every ounce of energy in my body, every fiber of my being is committed to making this a great city, its time to rebuild and to rebuild a better city.

to deal with right now is the Lower 9th Ward. Because it was hit so hard and so much of the infrastructure was damaged, but those other areas I think you're going to see a lot of activity back between now and the end of the year. It will probably be viable in two to three years, and the ninth ward may start redeveloping in about a year or two.

EB: Race has become an issue in this campaign, how would you assess the state of race relations pre and post Katrina, and how can we deal with the racial divide in New Orleans?

RN: I think pre-Katrina race relations were strained and relations between the races were superficial to a degree. We came together for Mardi Gras, Jazz Fest and some of the big cultural events, but for the most part economically we were divided. Post Katrina I think we dealt with some harsh realities, of the poverty and the images that went around the country; now with an economy that's getting ready to boom we have an opportunity to end this racial disparity economically. And I think if we do that that's going to allow more dialog and openness for a better New Orleans.

EB: We know of the horror that happened during Hurricane Katrina and its aftermath, in hindsight what is it that you would have done differently?

RN: Well there's three things I would have done differently. The first thing I would have interacted with the hurricane center a little closer, before the storm I had a window where I could have ordered a mandatory evacuation ten hours earlier. But I don't if it would have made a difference. The second thing is the buses, not the buses that were on TV, that was the school board buses, but the RTA buses that we moved to a place that never flooded but this time suffered flood damage, so I would move those out next time. And then third and finally, I would not wait for the state and the federal government to come save us after three days of being in a disaster; I would never do that again.

relationship with the mainstream media they've said a lot of things about Ray Nagin both good and bad. Do you feel you are portrayed fairly, and what is it that people do not know about Ray Nagin?

RN: The media have dealt with me in several ways. At one point they were portraying me as a superhero,



Statement Of Congressman William Jefferson

My attorneys tell me that it is not in my best interest to speak about the criminal investigation at this time. But I feel compelled to make a statement because I believe that my constituents are entitled to hear some response to the spate of recent publicity about me, and I have an obligation to think about your interests, as well.

Over the past nine months, my family and I have had to endure the hell of a federal criminal investigation. I have hoped that the government would come to understand that the actions under scrutiny were notillegal. Unfortunately, government seems inclined to view the facts in the worst possible light, and to characterize events that could be explained, or are exculpatory, in ways that tend to incriminate. In the end, I fear, the ends of justice are not served by this approach.



I wish to say emphatically that in all of my actions here under scrutiny, that I never intended to dishonor my office, or you, the public, and I certainly did not sell my office. Some of our friends have succumbed to the enormous pressure that the government has brought to bear, and in order to protect themselves, they have now characterized their relationship with me, or my family, in ways that fit neatly within the government's mistaken legal theories. This saddens me greatly, since these were people whom my family and I respected and with whom we enjoyed warm, personal relationships. Our support for them grew out of these relationships, not out of any agreements to use my official position in exchange for some monetary benefit. Our friendship and loyalty have been betrayed, and we fear that the truth has been compromised in the process. We pray that God will forgive them.

It will be only through a tortuous process that my family and I will be able to re-establish the truth. In this, we ask for the patience, if not the support, of the public. Indeed, when I began serving in Congress, there were two Congressmen, who happened to be African American, then serving in Congress under indictment by Federal prosecutors - Rep. Harold Ford, Sr. of Tennessee and Rep. Floyd Flake of New York. It took each of them over six years to establish their innocence. But in the end, they and their family members were found not guilty. They stayed in Congress and continued to do their jobs with the support of their people, as I am now continuing to deliver for the people of the district that I have been privileged to represent for nearly 16 years.

More recently, Mississippi Supreme Court Judge Diaz had the unfortunate experience of having his former wife plead guilty to some charge and testify against him. Nonetheless, he was found not guilty by a jury of his peers.

I therefore have not come here to announce my resignation. Far from it: I have come to declare, among other things, my continued intention to serve.

No one wants to be indicted. I certainly do not and I certainly do not want anyone - a family member or close associate - to be indicted. But I am prepared to answer these charges formally when and if the time comes. Unfortunately, as we await that day, there have been selective leaks of what is supposed to be confidential information from unidentified "law enforcement sources." Therefore, I ask the government to refrain from this process of death by a thousand cuts that generates salacious headlines and bad press for my family and to make no further public disclosures until it decides to close the matter and leave my family alone or to indict me and give me a reasonable opportunity to prepare my defense.

I would take full responsibility for any crimes that I committed if that were the case. But I will not plead guilty to something I did not do, no matter how things are made to look and no matter the risks. My family has insisted that I take this position, even if it causes

Commissioner of Insurance Jim Donelon Issues Urgent Medicare Enrollment Deadline Information



The Centers for Medicare & Medicaid Services has clarified its position on enrollment dates and penalties for seniors in Louisiana who enroll in Medicare Part D, according to Commissioner of Insurance Jim Donelon.

All Louisiana seniors must choose a Medicare Part D plan by Monday, May 15, unless they live in one of these Hurricane Katrina-impacted parishes: Acadia, Ascension, Assumption, Calcasieu, Cameron, East and West Baton Rouge, East and West Feliciana, Iberia, Iberville, Jefferson, Jefferson Davis, Lafayette, Lafourche, Livingston, Orleans, Plaquemines, Pointe Coupee, St. Bernard, St. Charles, St. Helena, St. James, St. John the Baptist, St. Martin, St. Mary, St. Tammany, Tangipahoa, Terrebonne, Vermilion and Washington.

ENROLLMENT CLARIFICATION FOR LOUISIANA A senior who DOES NOT live in a hurricane-impacted parish has until Monday, May 15 to enroll in a Medicare Part D plan, unless they already have credible prescription drug coverage of their own. If they miss the May 15 deadline, Louisiana seniors in non-impacted areas will not be able

to enroll in a Medicare plan until the next enrollment period, November 15 to December 31, 2006, with coverage that begins on January 1, 2007.


A senior who DOES live in a hurricane-impacted parish has until December 31, 2006, to enroll in a Medicare Part D plan, unless they already have credible prescription drug coverage. Once a senior in these impacted parishes enrolls in a plan, the prescription drug coverage begins the first day of the next month after they enroll. For example, if a senior enrolls in Medicare Part D on August 15, and they live in a hurricane-impacted parish, their Medicare Part D coverage begins September 1, 2006.

If a senior who lives in a hurricane-impacted parish does not enroll by December 31, 2006, he or she will have to wait until November 15, 2007, to enroll in Medicare Part D, just like all Louisiana seniors.

Beneficiaries and caregivers can call Medicare at 1-800-Medicare (1-800-633-4227) for help and to speak with a counselor. Your local Social Security office or the Social Security Administration (1-800-772-1213) can also provide assistance for those who may qualify.


additional repercussions or discomfort for them. As a family, we trust God to see us through.

Education law leaves children behind

'The day of reckoning is here, and it's not going to pass'

WASHINGTON (AP) – Not a single state will have a highly qualified teacher in every core class this school year as promised by President Bush's education law. Nine states along with the District of Columbia and Puerto Rico face penalties.

The Department of Education on Friday ordered every state to explain how it will have 100 percent of its core teachers qualified – belatedly – in the 2006-07 school year.

In the meantime, some states face the loss of federal aid because they didn't make enough effort to comply on time, officials said.

They are Alaska, Delaware, Idaho, Iowa, Minnesota, Montana, Nebraska, North Carolina and Washington, plus the District of Columbia and Puerto Rico.

"At some point there was, I suspect, a little bit of notion that 'This too shall pass,' " said Henry Johnson, the assistant secretary over elementary and secondary education. "Well, the day of reckoning is here, and it's not going to pass."

Department officials would not say how much aid could be withheld from states to force compliance. But Johnson said, "In some cases, we're talking about large amounts of money."

States often fell short because they did not report accurate or complete data about the quality of the teacher corps, said Rene Islas, who oversees the department's review.

The 4-year-old No Child Left Behind law says teachers must have a bachelor's degree, a state license and proven competency in every subject they teach by this year. The first federal order of its kind, it applies to teachers of math, history and any other core class.

In grading the states, the department found that 29 have made substantial progress. They must improve, but they do not face looming sanctions.

Twelve other states are still under review and haven't been rated: Colorado, Connecticut, Indiana, Maryland, Massachusetts, Missouri, Oklahoma, Pennsylvania, Rhode Island, Virginia, West Virginia and Wisconsin.

No matter which category they are in, all the states must submit a new plan of action.

Most states give themselves good grades on teacher quality; 33 states say 90 percent to 99 percent of their classes are taught by highly qualified teachers. Most of the rest put their numbers a tier below, in a range of 70 percent to 89 percent.

Data on Phone Calls Monitored Scope of Administration's Domestic Surveillance Unknown



The Bush administration has secretly been collecting the domestic telephone records of millions of U.S. households and businesses, assembling giant databases and attempting to sift through them for clues about terrorist threats, according to sources with knowledge of the program.

The "call detail records" enable U.S. intelligence agencies to track who calls whom, and when, but do not include the contents of conversations, the sources said, speaking on the condition of anonymity because they were not authorized to discuss the program. The companies cooperating with the National Security Agency dominate the U.S. telecommunications market and connect hundreds of billions of telephone calls each year. Intelligence analysts are seeking to mine their records to expose hidden connections and details of social networks, hoping to find signs of terrorist plots in the vast sea of innocent contacts.

U.S. intelligence chief John D. Negroponte When asked about the National Security Agency's controversial domestic surveillance program last Monday, objected to the question and said the government was "absolutely not" monitoring domestic calls without warrants.

"I wouldn't call it domestic spying," he told reporters. "This is about international terrorism and telephone calls between people thought to be working for international terrorism and people here in the United States."

Three days later, USA Today divulged details of the NSA's effort to log a majority of the telephone calls made within the United States since the Sept. 11, 2001, attacks – amassing the domestic call records of tens of millions of U.S. households and businesses in an attempt to sift them for clues about terrorist threats.

The disclosures last week about the scale of domestic surveillance – the most extensive yet known involving ordinary citizens and residents – touched off a bipartisan uproar against a politically weakened President Bush. reporters and sought to shape perceptions about the surveillance while declining to acknowledge that it is taking place. He said that "the intelligence activities I authorized are lawful," but specified no source of statutory or constitutional authority. He denied forcefully that his administration is "mining or trolling through the personal lives of millions of innocent Americans," saying, "Our efforts are focused on links to al-Qaeda and their known affiliates."

Neither Bush nor his subordinates denied any factual statement in the USA Today report, which said AT&T Inc., Verizon Communications Inc. and BellSouth Corp. have provided customer calling records to the NSA since shortly after the terrorist attacks of Sept. 11, 2001. Together those companies serve about 224 million conventional and cellular telephone customers - about four-fifths of the wired market and more than half of the wireless market. According to data provided by the research group TeleGeography, the three companies connected nearly 500

billion telephone calls in 2005 and nearly 2 trillion calls since late 2001.

The report in USA Today arrived as Air Force Gen. Michael V. Hayden, the president's nominee to be CIA director, faced tough scrutiny on Capitol Hill for his role in the interception of calls and e-mails between Americans and parties abroad. After the New York Times disclosed the eavesdropping in December, the White House dubbed it a "terrorist surveillance program" and said it involved only international communications by people with "known links" to al-Qaeda and its allies. The Washington Post reported in February that about 5,000 Americans had been subject to eavesdropping under the program and that nearly all of them had been cleared of suspicion.

Government access to call records is related to the previously disclosed eaves dropping program, sources said, because it helps the NSA choose its targets for listening. Critics reacted angrily, contrasting the new disclosures with the Bush administration's previous claims that domestic surveillance is narrowly targeted and restricted to international communications.

"Both the attorney general and the president have lied to the American people about the scope and nature of the NSA's program," said Anthony D. Romero, executive director of the American Civil Liberties Union. "It's clearly not focused on international calls and clearly not just focused on terrorists. . . . It's like adding more hay on the haystack to find that one needle."

Lawyers who specialize national security and communications, in and out of government, said it is difficult to assess the legality of the program because some of its features remain unknown. The Foreign Intelligence Surveillance Act, enacted in 1978, requires a court order before the government can eavesdrop on the content of domestic calls or keep live track of the phone numbers dialed by a U.S. telephone. But it does not cover wholesale acquisition of call records after the fact.

of customer records to third parties, including the government, but there are exceptions. With a court order, a subpoena or a "national security letter" from the FBI, a telephone company may be compelled to hand over records of specified individuals. In other circumstances, the law may be murkier.

According to USA Today, the telephonecompaniesareremoving the names and addresses of their customers from the records they give the NSA. But the government has many means of identifying account owners, including access to commercial databases from ChoicePoint and LexisNexis.

The statutes weren't drafted with the dragnet approach in mind," said Orin S. Kerr, a George Washington University law professor and former Justice Department lawyer. "And if this happened, who committed the violation? Is it the government or is it the phone company? It's really not clear."

Onegovernmentlawyerwhohas participated in negotiations with telecommunications providers said the Bush administration has argued that a company can turn over its entire database of customer records - and even the stored content of calls and emails - because customers "have consented to that" when they establish accounts. The fine print of many telephone and Internet service contracts includes catchall provisions, the lawyer said, authorizing the company to disclose such records to protect public safety or national security, or in compliance with a lawful government request.

"It is within their terms of service because you have consented to that," the lawyer said. If the company also consents, "and they do it voluntarily, the U.S. government can accept it."

Verizon's customer agreement, for example, acknowledges the company's "duty under federal law to protect the confidentiality of information about the quantity, technical configuration, type, destination, and amount of your use of our service," but it provides for exceptions to "protect the safety of customers, employees or property." Verizon will disclose confidential records, it says, "as required by law, legal process, or exigent circumstances."

Like the other companies named by USA Today, Verizon declined to confirm or deny that it had turned over customer records. "We do not comment on national security matters, we act in full compliance with the law and we are committed to safeguarding our customers' privacy," spokesman Thonis said in a statement. But Verizon Wireless, a joint venture with Britain's Vodafone Group PLC, denied involvement in the program.

An AT&T spokesman said in a written statement that it has "along history of vigorously protecting customer privacy" and provides records to the government "strictly within the law" but that "we don't comment on matters of national security." BellSouth spokesman Jeff Battcher said the company "does not provide any confidential customer information to the NSA or to any government agency without proper legal authority."
