

# The Power of the Dollar

A Prescription to Black Cities and the of Building Wealth
All Black Cities Part 5



Majority Black Cities such as Atlanta have become havens for Black seeking opportunities to acquire wealth and a better quality of life. Many other majority Black cities including New Orleans are beginning to remake themselves hoping to increasing Black wealth among its citizens.

During Black History Month Data News Weekly has given our readers a series on All-Black Towns. It was important for us to not only educate, but to inform and inspire our people of our storied past but our promising future.

For the last part of our series we asked Jeffrey May,

who is the owner of International Development and Planning, who for over two decades have worked with cities across America in the areas of providing access and equity in the area of housing for African Americans and other protected classes of people.

We at Data News Weekly believe that while they are no longer all-Black towns, but there are cities such as New Orleans and others that continue to be majority Black and issues of how people are empowered and build wealth are of paramount importance. We believe this is what will sustain these cities in the face of change, where in the face gentrification can absorb new people coming in but still retain a Black population that will not only survive but thrive.

### Fair Housing Planning: How to keep your community alive.

When I worked at the National Community Reinvestment Coalition (NCRC) as the Assistant Director of National Neighbors, the Fair Housing and

tigations and training as an Urban and Regional Planner, aptly qualified me to recommend approaches and initiatives to these banking and lending institutions. My objective was to not only foster compliance with the federal Fair Housing Act, as amended and Community Reinvestment Act in the mortgage lending and banking industry; but propose plans that would have a long-term positive impact in the af-

fected communities. So when I was asked by the Data News Weekly, what recommendations would I give to small predominantly Black towns and large cities across America to survive and grow, my advice is the same guidance my firm provides to cities, counties and states we work with across the Country. Whether you are small township or a megalopolis, and anything in between, to maintain your existence,

vitality, identity or anticipate future problems, your jurisdiction must embrace Fair Housing Planning.

Fair Housing Planning is an approach to the Consolidating Planning process that involves a lot of community engagement to find out from residents what is going on, in their communities; and how can government better address their needs. It emphasizes reaching out to those most vulnerable community members, persons with special needs, the homeless, at-risk youth and the elderly. And secondly, it requires a county, city or state to

analyze barriers to accessing housing through a civil rights lens to determine if disparities exist for federally protected classes under the Fair Housing Act, as amended. This federal law prohibits discrimination in housing and mortgage lending on the basis of race, color, religion, national origin, sex, disability and familial status. These forms of government using Fair Housing Planning to determine the needs of residents and deciding how to address them with Community Development Block Grant funds is akin to how a good medical doctor examines her patients.

Here is some information regarding our Notarial Archives.



The New Orleans Notarial Archives holds some 40,000,000 pages of signed acts compiled by the notaries of New Orleans, Louisiana, over three centuries. They reside in the only archive dedicated to notarial records in the United States. For centuries, citizens visited the local notary, or perhaps their family's notary, to execute agreements.

Since July 1970, records are filed directly in the Notarial Archives and receive an NA number for identification purposes.

The location of the Notarial Archives has changed over time. In 2005, Hurricane Katrina forced the rest of the Notarial Archives out of the courthouse basement and into new office space on the fifth floor of 1340 Poydras.

The Notarial Archives continues to preserve the valuable documents under its care and to make them accessible to the legal community, the academic research community, architectural historians, genealogists, and to the general public at large. Thanks to New Orleans' colonial legacy, the notarial record-keeping system that arrived with the French, endured through the Spanish, and survived Americanization created a wealth of historical documents that continue to this day to restore and refresh the city's rich cultural experience.







### Rev. William Barber's Poor People's Assembly and Moral March will be "Generationally Transformative"

NEW YORK - In the richest country in the world, 140 million people struggle with poverty and low wealth.

Over the last 50 years, the U.S. economy has grown 18-fold. Yet wealth inequality has exploded. The top 1 percent's share of the economy has nearly doubled, to more than 20 percent of our national income.

In 2017, the 400 wealthiest Americans owned more wealth than more than two-thirds of the entire U.S. population, and three individuals possessed a combined wealth equal to the wealth of 50 percent of the country.

The Poor People's Campaign, led by the Rev. Dr. William Barber II, is a national call for a moral revival. It is a continuation of the work of Dr. Martin Luther King, Jr., who was just beginning to build the campaign when he was assassinated in 1968.

On June 20, the campaign will lead the Mass Poor People's Assembly and Moral March on Washington, a "generationally transformative" gathering to demand that both major political parties address

the "interlocking injustices of systemic racism, poverty, ecological devastation, militarism and the distorted moral narrative of religious nationalism."

At the National Urban League's 2017 Conference in St. Louis, Rev. Barber delivered a powerful and inspirational message of justice, drawing parallels between Nebuchadnezzar, King of Babylon, and modern political figures.

"They were former slaves, and he was oppressing them in this historical moment because they were growing in power and influence and he saw this as the last chance to stop a growing diversity," Barber said of the Hebrew people. "He wanted to control their influence. He wanted to control their wealth. He wanted to control their faith. He even wanted to control their health."

He suggested that the nation is in a third reconstruction.

"The first reconstruction was from 1868-1880. The second reconstruction was from 1954-1968. when Black and brown and White people came together - par-

# **Kobe & Gianna Last Goodbye**

Vanessa Bryant was Solemn and Utterly Courageous





Vanessa Bryant gave an emotional farewell to her husband NBA Great Kobe Bryant and their daughter Gianna, who was killed in a plane crash. People filled the Staples Center to celebrate the life of the NBA great.

The widow of famed basketball legend Kobe Bryant and budding prodigy Gianna Bryant had been invisible and sparsely making Instagram post since that infamous day of January 26, 2020.

Vanessa Bryant, more than any other person, lost the most when her 13-year old daughter and doting husband of 20 years Kobe succumbed in that tragic helicopter crash that took their lives and seven others.

However, that all changed when "A Celebration of Life" honoring the victims was held at Staples Center on Monday February 24, 2020 nearly a month to the day that the Southern California region and basketball universe was dramatically altered forever.

Of the three memorials held at the arena that was built to host the Lakers, professional hockey, boxing matches and concerts there was something that distinguished each of them.



She loved watching cooking shows and "Cupcake Wars" with me. ... She loved watching "Survivor" and NBA games on TV with her daddy. ... She also loved watching Disney movies with her sisters."

As she clutched a white tissue she explained she would not be able to see GiGi as she was affectionately known attend high school with her sister, go on the University of Connecticut and then revolutionize the WNBA. She and Kobe would not be able to walk their daughter down the aisle in marriage and have children. It was beyond emotional as anyone who saw or heard could immediately connect to their own child.

ticularly in the South," he said. "And when we broke through the Southern Strategy and elected President Obama, that represented the possibility of a third reconstruction. What we see happening is a Nebuchadnezzar spirit that is trying to block the transformation of America. Nebuchadnezzar might be dead, but the spirit — that narcissistic stuff still lives."

That "Nebuchadnezzar spirit," he said, is evident in the massive voter suppression effort that has swept the nation since the gutting of the Voting Rights Act in 2013.

In addition to the Poor People's Campaign, Rev. Barber is President of the faith-based social justice organization Repairers of the Breach; Bishop with the College of Affirming Bishops and Faith Leaders; Visiting Professor at Union Theological Seminary; and Pastor of Greenleaf Christian Church, Disciples of Christ in Goldsboro, North Carolina.

He came to national attention

in 2015 when, as president of the North Carolina NAACP, he organized weekly protests at the State Legislative Building that were known as "Moral Mondays."

"Some ask the question, why don't they be quiet?" Barber wrote of the Moral Mondays protests. "Well, I must remind you, that it has been our collective silence that has quietly opened the city gates to these undemocratic violators of our rights. If we must pray forgiveness for anything today, it will be the silence with which we have allowed this to happen in the dark. Thoreau said in his famous essay, 'Civil Disobedience,' that if he had to repent of anything, it would be his good behavior. What possessed me, he asked himself, that I behaved so well in the face of such evil?

"As people of faith, we understand that we have been called to be the voice of the voiceless and the shepherd of God's beloved community. What we do here today is only what any responsible shepherd does to alert God's flock to the presence of the predators of democracy."

The Urban League Movement is proud to support the Poor People's Campaign and count ourselves as allies of Rev. Barber. We look forward to the Assembly and March in June.

### From the desk of MIKE BLOOMBERG

Dear Reader,

Thank you for taking the time to learn about The Greenwood Initiative.

As someone who has been very lucky in life, I often say my story would only have been possible in America – and that's true. But I also know that because of the artificial barriers of discrimination, my story likely would have turned out very differently if I had been Black, and that more Black Americans of my generation would have ended up with far more wealth, had they been white.

Building Generational Wealth for Black Families is Critical. That's why I launched The Greenwood Initiative in Tulsa last month. I visited the site of the Black Wall Street Massacre, where a white mob decimated the prosperous community of Greenwood. It is to the memory of the lost lives and promise of Greenwood that we've dedicated The Greenwood Initiative: a plan to address the systematic bias that has kept Black Americans from building wealth.

### THE GREENWOOD PLAN WILL:

- Create 1 million new Black homeowners
- Double the number of new Black-owned businesses
- Invest \$70 billion in the country's 100 most disadvantaged neighborhoods

Fixing the System for Black Families. When I was mayor of New York, I was proud to take on the systematic inequality that held back too many New Yorkers. We increased education funding, built 650 new schools and raised Black graduation rates to record highs. We led an ambitious effort to reduce poverty and managed the largest amount of affordable housing in the nation. And as President, I will work even more aggressively to combat inequality nationwide.

I understand that undoing generations of systematic discrimination won't happen overnight, but we can make progress with a clear vision and a comprehensive plan.
