The young women of Saint Katharine Drexel Preparatory School were treated to an unforgettable morning of wisdom, reflection, and inspiration during an exclusive Author Talk featuring Dr. Ruth J. Simmons, the Trailblazing Educator, Leader, and New York Times Best-Selling Author of Up Home: One Girl's Journey.

Organized by Alumnae Sheryl B. Neely (Class of 1964) and Karen Becnel Moore, in collaboration with the school's principal and staff, the event brought together generations of Drexel Prep women united by a shared commitment to education, empowerment, and legacy.

Dr. Simmons, daughter of a sharecropper, Dillard and Harvard University graduate, and the first African American President of an Ivy League institution (Brown University) captivated students with stories from her remarkable life journey. Her words resonated deeply as she encouraged the young ladies to remain

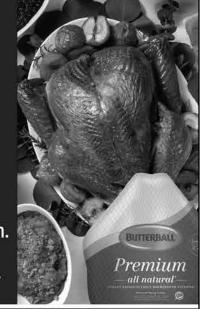

Original Stage Production Tells the Story of African Heritage in the African American Journey

Through rhythm, dance, and story-telling, Deacon Larry Calvin brought history to the center stage on Sunday, November 2nd. though his original play "Our Story in Words and Songs." The play explored African and African American History from the great African Kingdoms to slavery and emancipation, and eventually to the fight for Civil Rights.

"We have to know who we are and where we come from," Calvin said.

He said his inspiration for the work came from both faith and a need to educate. "I was inspired by the Holy Spirit," he said. "There's not enough real history taught in our schools."

Calvin worked with performers of all ages to bring this production to life. Young Gospel Dancers aged 8 to 15, seasoned choir members, and a live band kept the audience engaged throughout the play. Calvin said the different musical elements were essential to the play's message.

"Storytelling has always been part of who we are and the music - whether spirituals, freedom songs, or protest chants - it has always carried our people through," he said.

Calvin, who is a proud alumnus of Xavier University of Louisiana and graduated in the Class of 1969 and a long-time former Administrator, said his experiences at the university shaped the work that he continues to do for Civil Rights and Racial Equality in education and cultural preservation today.

"I hope the community and students realize the power they have to make a difference," he said. "That's what our ancestors fought for; to give us a voice and a purpose," he added.

Through "Our Story in Words and Songs," Calvin invited the audience to remember, reflect, and rise as a time when he said the current political climate aims to erase and "whitewash" histories and end diversity programs that ensure that Black Histories remain included in the American story. He said his message with this play is clear: knowing our history is key to shaping our future.

"If we don't tell our story," Calvin said, "someone else will, and they won't tell it the way it needs to be told."

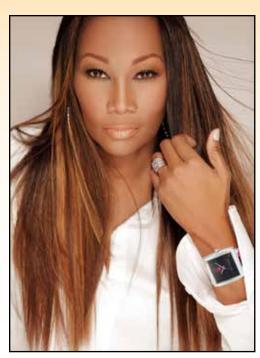

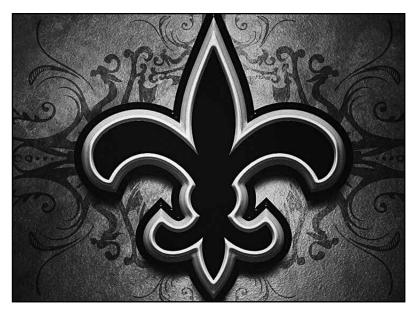
What's Up with the Black and Gold?

The streets of New Orleans are always alive with rhythm, resilience, and hope, but this football season, the beat feels off. With the Saints limping to a 1-8 start under new Head Coach Kellen Moore, the Who Dat Nation is asking a painful question: What's up with the Black and Gold?

When Kellen Moore was hired, optimism filled the Crescent City. A young offensive mind with a reputation for creativity, he was expected to breathe new life into a stagnant offense and re-energize a fan base craving the glory days of Payton and Brees. Instead, nine games in, the Saints look out of sync, struggling to find an identity on either side of the ball.

Moore's offensive schemes. once touted as innovative have too often looked predictable, inconsis-



tent, and disconnected from the talent on the field. The quarterback carousel continues to spin, the running game is sputtering, and the offensive line has offered little protection. It's a frustrating sight for fans who remember when the Superdome was home to precision, passion, and points.

Defensively, the story isn't much better. Once the backbone of the franchise, the Saints' defense now struggles to get off the field. Missed tackles, blown

assignments, and a lack of intensity have turned once-close games into blowouts. While Moore is an Offensive Coach, leadership starts at the top, and accountability must extend across the roster.

The bigger question looming over Airline Drive isn't just about X's and O's, it's about culture. Where's the fire? The swagger? The belief that used to define this franchise? Saints' fans have weathered hurricanes, heartbreaks, and heartbreak losses, but they've never accepted hopelessness. And right now, that's what this season feels like.

It's unfair to place all the blame on Kellen Moore. He inherited an aging roster, cap challenges, and a team searching for direction after years of inconsistency. Still, leadership means adapting, inspiring, and demanding excellence, and those qualities have been in short supply so far in 2025.

For this team to climb out of its

hole, it must rediscover its purpose. Veterans must lead with urgency, young players must step up, and Moore must find a way to light a spark in a locker room that's running low on confidence. The Saints don't just play for wins, they play for a city that bleeds Black and Gold, a city that knows how to come back from anything.

Right now, the fans aren't asking for miracles, they're asking for effort, heart, and pride. Because in New Orleans, the Saints aren't just a team; they're part of the city's soul. And the Who Dat Nation deserves a team that reflects that spirit.

As the 2025 season spirals, one thing is certain: it's time for Coach Moore and the Saints to look in the mirror, regroup, and remember what it means to represent New Orleans. Until then, the question echoes through the Dome and the neighborhoods alike... What's up with the Black and Gold?

Stretching from the South Shore of Lake Pontchartrain all the way to the Gulf of Mexico, Jefferson Parish is the largest parish by population in the Greater New Orleans region and recently celebrated its 200th Birthday.

At this week's State of Jefferson Address, Parish President Cynthia Lee Sheng outlined a new vision for turning Jefferson into a year-round Sports Destination. From turf fields and tennis courts to powerboat races and disc golf, major investments are underway to attract national tournaments, fill hotel rooms, and drive regional spending. These include:

The new John Alario Jr. Sports Complex, opening in 2026, which already has more than 30 events booked, from baseball and softball to football showcases that will bring thousands of athletes and families to the West Bank during the summer months.

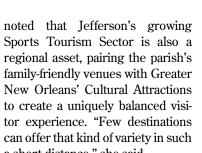


In Marrero, Parc des Familles will host the Disc Golf Pro Tour Big Easy Classic next March, a nationally streamed event expected to draw thousands of spectators.

Bright Playground is adding nine new courts as part of the Recreation Reimagined plan, positioning Jefferson to host state and regional tennis tournaments.

Lafreniere Park continues to anchor the parish's running and walking events, now including the new Park to Park 10K connecting LaSalle and Lafreniere.

Collectively, these projects are expected to generate nearly 20,000 hotel room nights in 2026. Sheng

25 States Suing Trump **USDA for Gutting Food Aid to 40 Million Americans**

Twenty-five attorney generals across the country and three governors have filed a lawsuit against the U.S. Department of Agriculture and its Secretary, Brooke Rollins, after the agency moved to suspend the Supplemental Nutrition Assistance Program, better known as SNAP, which helps more than 40 million Americans buy food each month.

The lawsuit, filed in Federal Court in Massachusetts, argues that Rollins and the USDA unlawfully halted the program despite having billions of dollars in contingency funds that Congress specifically approved for emergencies like the current Federal Government Shutdown. It names both the USDA and the Office of Management and Budget, led by Russell Vought, as defendants, accusing them of violating federal law and the Administrative Procedure Act by arbitrarily denying food assistance to millions of people who depend on it. "SNAP is the largest Anti-Hunger Program in D.C., and if these cuts are allowed to go through, tens of thousands of District children, seniors, and families will be unable to afford food," said District of Columbia Attorney General Brian Schwalb. "The adverse downstream impacts on public health, education, and public safety will be immediate, catastrophic, and irreparable. Additionally, the economic impact on our local business community will be severe as hundreds of SNAP retailers, including many that operate in food deserts, will lose a vital revenue stream. If these stores are forced to close, even non-SNAP recipients will lose access to critical sources of food."

According to the complaint, the USDA ordered states on October 24 to suspend all November SNAP benefit allotments until further notice, claiming insufficient funding due to the lapse in congressional appropriations. But attorney generals in 25 Jurisdictions argue that the agency's position is both unlawful and immoral, as Congress has already provided two separate \$3 billion Contingency Reserves

Food banks, many already overwhelmed, are bracing for surges in demand. Governors in several plaintiff states, including California and Minnesota, have already deployed Emergency Funds to keep families fed. Schwalb warned that the consequences go beyond hunger. "The ripple effects of this decision will reach every corner of our city," he said. "Children who are hungry cannot learn, seniors will face lifethreatening health risks, and small businesses will go under. This fight is about basic human decency and about keeping food on the table for those who need it most."
